Privacy Policy

of the Polish Astronomical Society

1. Introduction

1.1. This document describes the Privacy Policy of the Polish Astronomical Society with its registered office in Warsaw (hereinafter referred to as 'PTA').

The aim of this Privacy Policy is to determine the principles and manner of processing and using data and information obtained from the users of websites managed by PTA, social media (fanpages on Facebook, Instagram and Twitter), Urania – Postępy Astronomii (a web portal available at https://www.urania.edu.pl/) and an online shop available at https://sklep.pta.edu.pl/, as well as data and information obtained from the Members of PTA and other persons who provide their personal data to PTA in relation to activities defined in its charter. This Privacy Policy contains information on the rights of natural persons with regard to personal data they have provided.

The basis for this Privacy Policy is Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data and repealing Directive 95/46/EC (hereinafter referred to as the 'Regulation') and the Polish Personal Data Protection Act of 10 May 2018 (Dz. U. [Polish Journal of Laws] 2018, item 1000). This Privacy Policy implements Article 12 and 13 of the Regulation.

- 1.2. Please read this Privacy Policy carefully. By entering PTA websites or social media, using them or providing any personal data to PTA through these websites or by phone, email, post or personally at the registered office of PTA, the user accepts the provisions of this Privacy Policy.
- 1.3. This Privacy Policy applies to any website, application or service, as well as any instance of personal data processing which refers to this information. Please note that by leaving this page (for example by using a link to a website in a different domain), the user is transferred to an area in which this Privacy Policy is not in force. PTA will not bear any liability for privacy policies in force at websites managed by other entities.

2. Personal data controller

Polskie Towarzystwo Astronomiczne (the Polish Astronomical Society) with its registered office in Warsaw at ul. Bałtycka 18 is the controller of personal data provided by users of websites and social media managed by PTA, including the web portal Urania – Postępy Astronomii and an online shop, data published on Internet fora run or managed by PTA or any personal data acquired in relation to the activities of PTA with regard to which PTA determines the purpose and scope of processing. Personal data may be acquired as follows:

- indirectly, i.e. by obtaining information from business correspondence, data published by a natural person on social media or other data that are publicly available on the Internet, as well as by obtaining data from someone who is not the data subject,
- indirectly by filling out the form on PTA website, Urania Postępy Astronomii website or the online shop or by posting data on an Internet forum.
- directly, i.e. by phone, by email or during meetings, conferences and other industry events, as well as through personal contact.

The Polish Astronomical Society takes the utmost care to ensure that personal data are processed in accordance with the purpose for which they were collected and that they are used in accordance with the grounds and categories of processed data permitted by law. PTA takes the utmost care to ensure that the provided personal data are processed in accordance with the principles of personal data processing set out in Article 5 of the Regulation.

3. Purposes and legal bases for personal data processing

If there is a need to process your other personal data due to legal regulations, the features of a service or the necessity to settle the service, PTA may process such data to the extent necessary.

- 3.1. When you contact us via the contact form on the website managed by PTA, we process personal data such as: first and last name, phone number, email address.
 - The legal basis for such personal data processing is Article 6(1)(a) of the Regulation, which allows us to process personal data on the basis of voluntary consent. The provision of data and giving consent to their processing is voluntary, but refusal to give consent makes it impossible to contact PTA via the website.
- 3.2. In order to register a member who wishes to join PTA, we process: first and last name, email address, address of residence, business address, phone number and job position.
 - The legal basis for such data processing is Article 6(1)(b) of the Regulation, which allows us to process personal data when it is necessary for the performance of a contract to which the data subject is party or in order to take steps at the request of the data subject prior to entering into a contract. By joining PTA, its members accept the current charter and enter into a contract with PTA. If data is not provided, it is impossible to remain a member of PTA.
- 3.3. In order to carry out activities defined in the charter of PTA, including direct marketing and the collection of required membership fees, as well as to take other actions arising from the Charter of PTA, including publishing activities, we process first and last name, email address, address of residence, business address, phone number and image. The legal basis for such data processing is Article 6(1)(f) of the Regulation, which allows us to process personal data when it is necessary for the purposes of the legitimate interests defined in the charter and pursued by PTA as the personal data controller.
- 3.4. In order to set up an account in the online shop, we process: email address, first and last name.

 The legal basis for such personal data processing is Article 6(1)(a) of the Regulation, which allows us to process personal data on the basis of voluntary consent. The provision of data and giving consent to their processing is voluntary but refusal to give consent makes it impossible to shop in the online shop.
- 3.5. In order to process orders in the online shop and subscriptions for PTA publications, we process: email address, first and last name, address and payment data.
 The legal basis for such data processing is Article 6(1)(b) of the Regulation, which allows us to process personal data when it is necessary for the performance of a contract to which the data subject is party or in order to take steps at the request of the data subject prior to entering into a contract.
- 3.6. In order to enable users to participate in online fora, we process: email address and the user's login and nick, which in certain circumstances may contain information which makes it possible to identify a natural person. The legal basis for such personal data processing is Article 6(1)(a) of the Regulation, which allows us to process personal data on the basis of voluntary consent.
- 3.7. In order to organise and carry out competitions, we process: the participant's first and last name, email address, address, phone number and the image of winners.
 The legal basis for such data processing is Article 6(1)(a) of the Regulation, which allows us to process personal data on the basis of voluntary consent of the data subject, and Article 6(1)(b) of the Regulation, which allows us to process
 - personal data when it is necessary for the performance of a contract to which the data subject is party or in order to take steps at the request of the data subject prior to entering into a contract.
- 3.8. In order to develop, publish, print and distribute PTA publications, also in electronic form, we process: first and last name, phone number, email address, address and the image of authors, as well as data on their academic achievements and education.
 - The legal basis for such data processing is Article 6(1)(a) of the Regulation, which allows us to process personal data on the basis of voluntary consent of the data subject, and Article 6(1)(b) of the Regulation, which allows us to process personal data when it is necessary for the performance of a contract to which the data subject is party or in order to take steps at the request of the data subject prior to entering into a contract.

- 3.9. In order to provide services to the users of an application called AstroGPS, whose creator is PTA, we process geolocation data of registered application users: first and last name, nick, email address or Google/Apple/Huawei identifier.
 - The legal basis for such data processing is Article 6(1)(a) of the Regulation, which allows us to process personal data on the basis of voluntary consent of the data subject, and Article 6(1)(b) of the Regulation, which allows us to process personal data when it is necessary for the performance of a contract to which the data subject is party or in order to take steps at the request of the data subject prior to entering into a contract. Such data are also processed by PTA for statistical purposes, pursuant to Article 6(1)(f) of the Regulation, i.e. for purposes of the legitimate interests defined in the charter and pursued by PTA as the controller of personal data, i.e. the development of the application.
- 3.10. In order to provide services to the users of an application called Astrotravel (Astroturystyka), whose creator is PTA, we process geolocation data of registered application users: first and last name, nick, email address or Google/Apple/Huawei identifier.
 - The legal basis for such data processing is Article 6(1)(a) of the Regulation, which allows us to process personal data on the basis of voluntary consent of the data subject, and Article 6(1)(b) of the Regulation, which allows us to process personal data when it is necessary for the performance of a contract to which the data subject is party or in order to take steps at the request of the data subject prior to entering into a contract. Such data are also processed by PTA for statistical purposes, pursuant to Article 6(1)(f) of the Regulation, i.e. for purposes of the legitimate interests defined in the charter and pursued by PTA as the controller of personal data, i.e. the development of the application.
- 3.11. In order to organize conferences/workshops/lectures/summer schools, we process the name and surname, telephone number, e-mail address, address of the participants of these events and data regarding their scientific achievements and education. We also process the image of the participants of these events for the purposes of handling a given event, internet broadcasts, broadcasts and reports in the media, archival and promotional materials regarding the event. This means that the event (including its participants) may be photographed and filmed for the purposes indicated in this point, including the publication of photos and recordings.

 The legal basis for such data processing is Article 6(1)(a) of the Regulation, which allows us to process personal data on the basis of voluntary consent of the data subject, and Article 6(1)(b) of the Regulation, which allows us to process
 - on the basis of voluntary consent of the data subject, and Article 6(1)(b) of the Regulation, which allows us to process personal data when it is necessary for the performance of a contract to which the data subject is party or in order to take steps at the request of the data subject prior to entering into a contract. Such data are also processed by PTA for statistical purposes, pursuant to Article 6(1)(f) of the Regulation, i.e. for purposes of the legitimate interests defined in the charter and pursued by PTA as the controller of personal data, i.e. the development of the application.
- 3.12. Moreover, PTA processes personal data for archiving purposes in the public interest, scientific or historical research purposes or statistical purposes in accordance with Article 89(1) of the Regulation. In this case, the legal basis for data processing is Article 6(1)(f) of the Regulation, which allows us to process personal data when it is necessary for the purposes of the legitimate interests defined in the charter and pursued by PTA as the personal data controller.

The Polish Astronomical Society does not process personal data which belong to special categories of personal data as defined in Article 9 of the Regulation.

4. Personal data recipients

The Polish Astronomical Society declares that it does not sell, share or transfer the users' personal data collected for processing to other persons or institutions, unless it happens with the user's express consent or at the user's request, or at the request of state authorities authorised to do so by the statute for purposes of proceedings carried out by them or activities related to security or defence, in relation to tasks established by law and carried out for the public good, when it is necessary to fulfil the legitimate purposes of PTA defined in its charter. However, we would like to inform you that in order to process orders in the online shop, your payment data may be available to payment operators, such as Dotpay, PayU, FirstData (Polcard), BLIK, Visa and MasterCard, whereas addresses may be available to entities which deliver purchased goods or publications. Moreover, some data may be available to entities which provide a specific service (e.g. your email address may be given to an entity which sends the newsletter that you subscribed to) and any data saved in IT systems will be available to entities which provide the hosting service.

5. Transferring personal data to countries outside the European Economic Area

In the territory of the European Union personal data are protected by common legislation on personal data protection. In other countries, such data may not be protected to the same degree. Prior to transferring information on the user to a country outside the European Economic Area (EEA), PTA is obliged to make sure that that country will adequately protect the user's rights. The European Economic Area includes member states of the European Union, Norway, Iceland and Liechtenstein.

The Polish Astronomical Society does not transfer your personal data to any entities located in third countries outside the European Economic Area. An exception are situations in which such a transfer is required to carry out a given service or is a part of an international project (after making sure that the entity providing the service or the project partner uses adequate data processing procedures and has established an adequate privacy policy) – such exceptional situations are described in points 12.3-12.63.

6. The period of personal data processing

The Polish Astronomical Society processes personal data for a period required to achieve purposes described in Point 3 of this Privacy Policy, but not longer than for 3 years from the date such data were obtained, with the stipulation that:

- in the case of PTA membership, personal data will not be processed longer than for the time when membership lasts:
- in the case of personal data processed on the basis of a consent given by a natural person, such data will be processed until the consent is withdrawn;
- in the case of data processed on the basis of the controller's legitimate interest or for the purposes of direct
 marketing, such data will be processed until the data subject objects to the processing, but not longer than for 3
 years;
- in the case of personal data processed mainly for analytical purposes, to use cookie files and to manage the
 website, as well as geolocation data, such data will be processed until they become outdated or are no longer
 useful, but not longer than for 3 years;
- in the case of data related to the processing of an order in the online shop, such data will be processed from the time provided for in applicable laws until the establishment, exercise or defence of legal claims;
- in the case of other data, the data will not be processed longer than for a year after the legal basis for their processing expires.

In the case of personal data processed pursuant to Article 6(1)(a) of the Regulation, we would like to inform you that such data will be processed only until you withdraw your consent or when the purpose for which they were collected ceases to exist. Consent may be withdrawn at any time, which will not affect the lawfulness of processing based on consent before its withdrawal.

7. Rights of data subjects

The Polish Astronomical Society respects every person's rights related to the processing of their personal data. In particular, every person whose data are processed has the right to:

- access their personal data,
- rectify their personal data,
- erase their personal data ('right to be forgotten')
- restrict personal data processing,
- · object to personal data processing,
- request the transmission of their personal data;

When it comes to the right to object, you have the right to object at any time to personal data processing pursuant to the legitimate interest, for purposes such as direct marketing or profiling or for statistical purposes, on grounds relating to your particular situation. However, PTA may leave data that identify a natural person in a data set solely to prevent a situation in which the same person's data would be used again for purposes to which that person objected.

The Polish Astronomical Society would like to inform you that it is not obliged to erase data (exercise the 'right to be forgotten') in case data processing is required in order to:

- exercise the right to information and freedom of speech,
- fulfil the legal obligation to process data under the law of the European Union or Polish law, or to complete a task carried out in the public interest,
- achieve archiving purposes in the public interest, scientific or historical research purposes or statistical purposes,
- establish, exercise or defend claims.

If personal data are processed on the basis of the consent of the data subject or on the basis of a contract and processing is automated, the data subject has the right to receive the personal data concerning them at their request, in a structured, commonly used and machine-readable format and has the right to transmit such data to another controller in that format. When the data subject submits a request for the transfer of personal data, they also need to specify whether the personal data concerning them should be erased ('right to be forgotten') by PTA and submit a relevant request in this regard.

The above rights and the intention to withdraw the consent to the processing of personal data may be exercised and submitted in the following ways:

8. Automated decision-making and profiling

The Polish Astronomical Society does not make decisions by automated means, which includes profiling.

9. Information security and storage

The Polish Astronomical Society ensures the security of personal data and protects such data against being accessed by unauthorised persons, taken over by unauthorised persons, destroyed, lost, damaged or changed and against personal data processing which does not comply with the provisions of the Regulation. In order to protect the provided personal data, PTA takes technical and organisational measures which meet the requirements of the Regulation, in particular measures listed in Article 24 and 32 of the Regulation, which ensure confidentiality, integrity and availability of personal data processing services.

10. Right to lodge a complaint

Whenever it is determined that the rights of a natural person arising from legal provisions and this Privacy Policy are violated, you have the right to lodge a complaint with the Personal Data Protection Office (UODO) with its registered office in Warsaw, at ul. Stawki 2.
